Chairperson's message



The Wyatt Trust is now in its 139th year and our Board and staff are committed to making our practice meaningful and contemporary. Wyatt may only be a small part of a vast system working on issues of inequality and poverty, but as a philanthropic trust we have the privilege of flexibility like few others. We constantly look at the impact of our actions to guide direction, and this past year is no exception.

In early 2025 Wyatt published its first Issues Report on valuing and embedding Lived and Living Experience. We continue to learn from those who contribute to this work.

Alongside our core work of providing grants, we track the impact of our financial investments to ensure that they too contribute to our mission. We were thrilled to be a finalist in the national Impact Investing Awards for Impact Asset Owner of the Year. This year also saw our first direct investments in local enterprises benefiting people and planet through Wyatt's own initiative, the Catalytic Local Investment Fund.

This year saw the conclusion of the Bultawilta Schools program, which began in 2006 when Wyatt partnered with two schools on financial support for Aboriginal students and their families. The program grew to 23 schools, and \$1.2 million was delivered through Aboriginal education teams.

The Wyatt Board continues to grapple with our responsibilities to Aboriginal peoples from the knowledge that the vast proportion of the Trust's wealth derives from land purchased by William Wyatt which is stolen land. We continue to engage with Aboriginal leaders to shape our decisions in programs, investments and appointments.

Wyatt is an implementation partner for Foundation SA, which is entering its fifth year of operation. Always intending to be independent of Wyatt, the Foundation has taken another big step forward by appointing an independent governance board. Foundation SA now has 47 sub-funds and has distributed more than \$2 million to charitable organisations across South Australia and beyond.

On behalf of the Board, I thank Wyatt staff for their dedication, skill and advice on all fronts. Stacey Thomas has provided energetic and skilful leadership to the organisation and to the broader philanthropic sector.

For 13 years, The Wyatt Trust benefited greatly from the expertise and energy that Anne McCutcheon brought as a Board member. Anne completed her term in 2024, and we welcomed Owen Sharpe to the Board. I thank my fellow Board members for their expert and considered engagement, and their commitment to the purpose of such a vital philanthropic organisation.

CEO's message



This year's Annual Report follows a pared back format that is designed to be read in conjunction with our Impact Report, the first of which was published in 2025. The Annual Report naturally includes all the year's financials, but the stories of impact and insights from the year's work can now be found in the annual Impact Report. We know we are a small piece in a very big jigsaw when it comes to shifting poverty, but we believe the instances of impact outlined there are contributing to broader change for people experiencing financial hardship.

In FY2024/25 we deepened relationships and continued to sharpen our grant making focus, with \$3.98 million in total grants distributed. These included Partner Grants which accounted for \$2.86 million, shared across 41 partner organisations and five grant programs, supporting 4,166 South Australians; and our Direct Grants program which provided \$594,000 to individuals experiencing financial hardship, with 724 households supported.

Our grant partners continue to experience an extremely high demand for support from clients, with financial challenges exacerbated by ongoing cost of living pressures and rising rents. Our co-designed Linker Service completed its first 12 months of service delivery, supporting 129 clients across the state. Along with the five Linker roles, the Service now includes two Peer Workers and an Intake Officer.

The commitment to sharing what we learn was a key theme of our work this year, with several new communications delivering an honest appraisal of our experiences with Truth-telling and embedding Lived and Living Experience across our grant making, program design and beyond.

The initial presentation of Wyatt's <u>5 learnings from Truth-telling</u> at the Philanthropy Australia national conference opened many new conversations and forged new relationships within and beyond the sector. Similarly, the publication of the <u>Valuing and Embedding Lived and Living Experience Report</u> in April sparked strong engagement from philanthropy peers, government departments and not-for-profits. In both cases, we have been humbled by the response and grateful for the many opportunities these communications unlocked.

The shared evaluation workshops, now a biannual feature of our Stable Housing and Financial Wellbeing programs, have been heartily embraced by our grant partners, with some now choosing to use this approach to learning with other funders.

In team movements this year, we farewelled Mary Shaw and welcomed Nicole Richards and Michelle Quach. I consider myself fortunate to work with a talented and committed team and thank them for their hard work again this year. Thank you also to our Chair, Pam Simmons and our Board members for their ongoing support and to our grant partners and Lived and Living Experience colleagues who bring this work to life.
